

Insurance overview

The terms and conditions of this overview apply to all machines and / or equipment from Doornbos Equipment BV and affiliated companies, hereinafter referred to as Doornbos, which are rented in accordance with a rental agreement.

Cover

Cover is in accordance with the terms of the "Nederlandse Beurspolis voor Landmaterieel 2006" and limited to rental within Europe, in accordance with the insurance terms of Schouten Zekerheid Makelaars in Assurantiën B.V.

W.A.M. conditions

The W.A.M. risk (Motor Insurance Liability Act) is covered by default and you will not be charged a premium. The maximum insured sum per occurrence is:

- € 2,500,000 for material damage
- € 7,500,000 for physical injury
- € 1,000,000 for damage to facilities below ground level (KLIC notification required)

Hull conditions

The Hull risk will be insured additionally. For this Insurance, a premium of 5% of the standard list price applies. The premium will be charged automatically unless you have arranged your own Hull insurance before signing the rental agreement. In this case, you must take out hull Insurance on behalf of the machine. If the machine is lost or damaged, the compensation must be paid to Doornbos Equipment BV. The client is obliged to inform his insurers of this obligation and hand over a copy of the proof of Insurance to Doornbos. Cover excludes damage to tires, hoist wires, lights, windows and mirrors.

Further exclusions, both for W.A.M. as well as Hull insurance, are in accordance with Article 5 of the "Nederlandse Beurspolis voor Landmaterieel 2006" (including: nuclear core reactions, armed conflict, improper use, intent and negligence).

Excess per item, per event:

- € 2,500.00 for Hull damages.
- € 1,250.00 for W.A.M. damages.
- € 2,500.00 for registered vehicles and W.A.M. damages to all types of pavement, greenery and so on.
- € 5,000.00 in case of fire, theft and total loss

Excess charges mentioned are at the expense of the client and are always subject to damage incurred during rental period of the machine. If any damage with or to the machine occurs outside this period, the excess is equal to the amount of the damage caused.

In case of damage, the client should try to limit the damage. Any damage should be reported immediately to Doornbos. Damage to third parties not covered by the liability insurance shall be borne by the client, which indemnifies Doornbos for all third party claims in this regard. Any damage to the clients property, rented premises or equipment, is not covered by this insurance. This also applies to hoisting loads. In case of theft / vandalism, the client must report to the police and submit a copy of the Police report to Doornbos immediately. All damage caused to Doornbos as a result of non-compliance with these obligations shall be borne by the client.

The General Rental Conditions of Doornbos Equipment BV apply on all our rental agreements as last deposited with the Chamber of Commerce in Rotterdam. A copy can be downloaded from our website www.doornbosequipment.com/downloads.
